Social Membership Terms and Conditions

The undersigned certifies that the information and facts provided in this application are true and correct. The undersigned further agrees to be bound by and accepts the terms and stipulations set forth in the By-Laws of the Club and all rules and regulations enacted by the Governing Board of the Jeremy Golf and Country Club regarding privileges associated with this Social Membership.

The undersigned understands and authorizes The Jeremy Golf and County Club to obtain appropriate credit card authorization to establish the validity of their credit card as a basis to open a private Social Membership account with The Jeremy Golf and Country Club.

All food and beverage purchases must be billed to the social members account or paid with a credit card. The undersigned agrees and accepts full and complete responsibility for any and all charges made on their Social Membership account. All golf shop merchandise sales must be paid for at the time of purchases. Charging Golf Shop merchandise to your private Club account is not permissible.

Social Members are offered the option of paying their monthly charges with our automatic credit card payment plan. With established terms a monthly statement will be mailed to you, for your records.. The undersigned authorizes The Jeremy Golf and Country Club to bill their credit card under the established terms. If the credit card transaction is denied the social member's account will be closed, pending a new valid credit card authorization. If the Social Membership account is closed, the annual fee is non-refundable.

Social Membership privileges do not include: access to the golf course, practice facilities, or use of reciprocal clubs. You are always welcome to come as a guest of an equity member in accordance with our guest policies. An exception to use the golf course will be granted for social members who purchase the Basic Social Membership plus Two Rounds of Golf when they are playing these two rounds only. This exception will also apply to the junior who is approved to participate in the Junior League and Junior Clinic program by purchasing a Basic Social Membership plus Junior Limited Golfing Privileges.

A Social membership at the Club allows you and your immediate family, which includes your spouse and all children living at your residence under age 26, use of the golf shop, restaurant, and banquet facilities. As a Social Member you have the privilege of bringing guests to the Club. Guests are not permitted the use of Club facilities unless they are accompanied by you, the member.

The Club shall consider possession of the "Identification Charge Card" to be evidence that the holder has authorization for its use by the undersigned. In the event of a lost or stolen "Identification Charge Card", the undersigned shall accept responsibility of notifying the Club of the loss in writing and verbally. The undersigned further accepts responsibility for the usage of such card prior to the notification of it's loss to the Club. The undersigned further acknowledges that all membership cards are the property of the Club and will surrender the same upon receipt of written demand from the Club.

The Jeremy Golf and Country Club reserves the right to terminate social membership privileges for conduct unbecoming by a Club member, account delinquency and any other reason deemed appropriate by the Board of Governors. No refunds will be issued for terminated social memberships. Social memberships are valid from the date issued until December 31, 2012.
