# Social Membership Terms and Conditions

The undersigned certifies that the information and facts provided in this application are true and correct. The undersigned further agrees to be bound by and accepts the terms and stipulations set forth in the By-Laws of the Club and all rules and regulations enacted by the Governing Board of Jeremy Ranch Golf and Country Club regarding privileges associated with this Social Membership.

The undersigned understands and authorizes Jeremy Ranch Golf and Country Club to obtain appropriate credit card authorization to establish the validity of their credit card as a basis to open a private Social Membership account with Jeremy Ranch Golf and Country Club.

All food and beverage purchases must be billed to the social members account or paid with a credit card. The undersigned agrees and accepts full and complete responsibility for any and all charges made on their Social Membership account. ***All golf shop merchandise sales must be paid for at the time of purchases.*** Charging Golf Shop merchandise to your private Club account is not permissible.

Social Members are required to include either bank account ACH or credit card information to be set up in our EZ Pay billing system. With established terms a monthly statement will be emailed to you, for your review and the balance due for each month will be processed on or near the 20th of the following month. If the ACH or credit card transaction is denied the social member's account will be closed, pending a full payment and a new valid bank account ACH or credit card account number. If the Social Membership account is closed, the annual fee is non-refundable.

Social Membership privileges **do not** include: access to the golf course, practice facilities, or use of reciprocal clubs or the fitness center. Social members may play as a guest of a Golfing Privileges member in accordance with our guest policies. An exception to use the golf course will be granted for social members who purchase the plus two or four rounds of golf when they are playing these two or four rounds only.

A Social Membership at the Club allows you and your immediate family, which includes your spouse/partner and all children living at your residence under age 18, use of the golf shop, restaurant, and banquet facilities. As a Social Member you have the privilege of bringing guests to the Club. Guests are not permitted the use of Club facilities unless they are accompanied by you, the member.

The Club shall consider possession of the "Social Membership Card" to be evidence that the holder has authorization for its use by the main account holder. In the event of a lost or stolen "Social Membership Card", the main account holder shall accept responsibility of notifying the Club of the loss in writing and verbally. The main account holder further accepts responsibility for the usage of such card prior to the notification of its loss to the Club. The main account holder further acknowledges that all membership cards are the property of the Club and will surrender the same upon receipt of written demand from the Club.

Jeremy Ranch Golf and Country Club reserves the right to terminate social membership privileges for conduct unbecoming by a Club member, account delinquency and any other reason deemed appropriate by the Board of Governors. No refunds will be issued for terminated social memberships. Social memberships are valid from date of purchase through December 31 of the approval year and are automatically renewed until notice to terminate is received via email or letter.
